# Concerned residents demand DNA tests for two suspected pit bulls at Montebello

it bulls: the mere words immediately conjure up images of snarling, vicious dogs with steel-trap jaws mauling other animals and children. But for many others, they are obedient, intelligent, affectionate family pets that are eager to serve and please their masters. Either way, people have strong feelings about pit bulls and are firmly divided into two opposing camps.

Recently, a widely circulated email (see page 4) has informed the residents that two suspected pit bulls live at Montebello, in violation of Montebello bylaws that prohibit pit bulls from getting onto the property. "The term pit bull is defined as any dog which is entirely or part American Pit Bull Terrier or American Staffordshire Terrier or any combination thereof, including any related breeds," the by-laws state.

Furthermore, as all Montebello dog-owners know, they are "required to provide for the Association a fully executed Certificate of Vaccination and Identification of Breed in the form approved for use by the Board of Directors. Such Certificate of Vaccination and Identification of Breed duly executed by a veterinarian shall be used to determine whether a dog is or is not of the pit bull variety," the bylaws state.

According to Assistant General Manager Marco Mendoza, owners of both dogs in

### The U.S. heads, without a plan, into its most vital election

merican voters and political parties were, by the close of March 2016, well down the path toward selecting the final candidates for the November 2016 presidential election. 
probed this vacuum.

World Wars I and II did not, with the balance of hindsight, present the challenges to Western survival and U.S. leadership which the demographic, economic, social, and security threats of the coming decades will pose.

Significantly, all the candidates but one, Hillary Clinton, have based their premise for election on opposing virtually all of the actions and policies of incumbent President Barack Obama, and yet all, without exception, have accepted the overt as well as covert agendas of Mr. Obama in the global environment. These include the continued U.S. engagement in provoking and sustaining war in Syria (with its consequences for the destabilization of Europe and support of a rogue Turkey); the unrelenting anti-Russian "new Cold War" which has divided post-Soviet Russia

from Europe and driven it into the arms of the People's Republic of China; and an ill-considered approach on how to compete with the PRC.

In short, the Obama White House, which has been ideologically-driven, rather than U.S. interests-driven, has dictated the agenda for the competing candidates. The U.S., under the next president, will, then, either pursue strategic policy under the terms set by Obama, or will have to start reformulating and reconstructing a viable global strategic policy. To do that, the successful candidate will have to undo the year or more of jingoism and then re-educate the U.S. polity about the reality of the global strategic terrain. In other words, he or she must undo, and reverse, the mindset and demonizing the campaign has helped to reinforce in Washington, and among the U.S. electorate at large.

Moreover, for perhaps the first time, the ongoing U.S. presidential election process has exposed the reality that the Democratic Party nominating process is about the top-down imposition of its preferred candidate upon the party and its members. The primaries and caucuses, supposed to deliver delegates to the final convention as determined by the state-by-state events, in fact count for little. The party's nomenklatura selects "super delegates" who have predetermined the outcome. The preferred candidate on this occasion is Hillary Clinton, but the process may yet be undone by criminal charges against her for unambiguous violations of security procedures when she was secretary of state. Or by her own health issues. Her skeletons are out of the closet, but are never discussed.

There is little doubt that the Obama White House, conscious of the reality that a future president could undo the work of Barack Obama, is clearly ready to re-inject Vice President Joseph Biden into the race, or even Secretary of State John Kerry, or former New York City Mayor Michael Bloomberg,

should Hillary's candidature become untenable.


The Republican Party, thrown from its path by the initial success of non-politician Donald Trump, has – as is typical in the party's primary process – focused on the cat fight to determine the candidate, and has steered itself far from substantive discussion of economic policies, foreign policies, defense policies, or social policies. That is not as damaging as the fact that it has spent the time reinforcing an endorsement of what have been destructive U.S. policies on defense and foreign and strategic policy. This, truly, is an example of Rome burning while Nero fiddles.

The U.S. electorate knows that all is not well, which is why it has done the only thing open to it: to support the "anti-candidates," Trump and socialist Bernie Sanders. But ultimately the electorate has become victim of a process determined by power groups. Thus is "democracy" continually redefined and its essence replaced by a manipulable calculus; the same manipulation of democracy which the world criticized in the USSR.

Could any of the candidates begin now to think on, and expound, theories for the successful revival of U.S. strategic fortunes? Why not? U.S. politicians, however, have an inherent fear of disclosing any concrete plans, for fear that they could be criticized. Safer to claim that only they could make "America great again," or provide the requisite bread and circuses to appease the entitlement generation. But this neglect of substance holds the entire world in its thrall of ignorance. This is hardly the visionary and courageous stance of a Thomas Jefferson, or Teddy Roosevelt, or Ronald Reagan.

But what is that catchy circus tune which Nero now plays for us?

### Pit bulls pose danger to Montebello residents and other dogs

Note: This is a slightly abridged version of the email that was sent out to the residents at the end of March.

hanks very much to those of you who signed individual letters asking the Montebello management and Board of Directors to take some action to confirm whether the two dogs who appear to be pit bulls living at Montebello are actually pit bulls or the breeds that the owners of the dogs are alleging.

The specific action that was requested was for the management to require DNA tests of the dogs – which initially sounds extreme - but is not invasive. This \$69.95 testing requires a swab in the dog's cheek. We requested that form of breed confirmation because the two owners were representing their dogs as other breeds - and if someone is willing to present fraudulent paperwork once we felt paperwork would likely again be fraudulent if they were allowed to present additional paperwork to confirm the breed of these two dogs. If these owners believe their dogs are NOT pit bulls, then they should willingly submit their dogs to the DNA test.

None of the three people (including myself) who initiated and followed up on the requests for action to confirm the breed of these dogs hates pit bulls. We simply want the existing by-laws enforced and these dogs to be removed from the property if they are pit bulls — as everyone who sees them suspects they are.

Pit bulls should not be living in a high-rise community (where pit bulls are banned) where they encounter other dogs and people in enclosed areas like elevators. If a small dog growls at one of the pit bulls or engages it aggressively, the pit bull will likely kill the small dog and may injure the owner.

These dogs are clearly an insurance liability – as many insurance companies won't insure homeowners with this breed. An Internet search reveals that the average pit bull attack results in a \$25,000 insurance claim. You as resident owners will be the ones paying this when condo fees rise.

The first complaint (in writing) asking management to remove the pit bull in Building 2 was submitted to the management and was copied to multiple Board members in April of last year. Following that complaint, General Manager Liz Foltin stated in a Planning & Design meeting (crowded with residents to try to stop the installation of K9 grass) that the dog in Building 2 would be off the property in two weeks. I was there and she stated it to everyone when I brought up the pit bulls. I was the initial person who com-

plained in writing about the first dog I saw. Those two weeks have stretched to a year now and management has allowed the dog to stay.

Here we are, a year later, and after multiple additional complaints in writing, meetings with Marco [Mendoza] and Liz and concerns expressed to Board members, the management and Board have allowed the dog owners to re-register the dogs and accepted the breed on the vaccination form as confirmation of breed. Why did the dog owners have to register the dogs again and prove they were vaccinated?

The dog owner continues to claim that the dog in Building 2 is an American

Bulldog and the dog in Building 3 is a Rhodesian Ridgeback. The vaccination forms are simply forms that the dog owner completes and writes the breed in when they register the dog with the state/county. I wrote my dog's breed on my forms and no one questioned the breed.

Supposedly the attorney for Montebello determined that they had to do NOTHING but have the dogs registered. A quick Internet search on legal actions related to pit bull attacks clearly shows that if management had any inkling that these dogs are pit bulls and allows them to stay here and a pit bull attacks a dog or person (or both, as most dog owners would try to protect their dogs), then the association is liable.

The multiple written complaints make it clear that management is aware. Management is claiming they have no right to obtain further proof of the breeds of these dogs, but clearly they do. The by-laws do not state that the confirmation by vaccination certificate is the ONLY form of breed confirmation that can be requested. When I moved here 10 years ago, the by-laws were the same and I was required to bring in a statement from a local veterinarian clearly saying that my dog (miniature dachshund) had NO PART pit bull to be able to register the dog at Montebello.

Those of us who initiated the first complaints have requested that the management review the current decision and take additional action to confirm the breed of these two dogs — hopefully the response won't take a year!

question have submitted the required paperwork, which lists the breeds as American Bulldog and Rhodesian Ridgeback – neither pit bulls nor part American Pit Bull Terrier or American Staffordshire Terrier.

However, a number of Montebello residents with extensive knowledge about dog breeds have no doubt whatsoever that based on their distinct physical characteristics, these two dogs are, in fact, pit bulls and must be removed from the property to prevent any potentially tragic incidents. These residents are also certain that the owners of these two dogs wrote false dog breed information in their registration documents.

Thirty-eight residents have sent letters to the management requesting giving these dogs a DNA test to prove their pedigree. Although no incidents of aggressive behavior toward people or other animals have been reported, these residents believe the presence of two likely pit bulls is like a time bomb.

So here is the problem: some residents are absolutely certain that these two dogs are pit bulls and violate Montebello's by-laws. Management says that all necessary paperwork states that these dogs are not pit bulls and has no legal claim to remove them from the property. When reached for comment,

one of the dog owners angrily declined to comment; the other dog owner could not be reached.

After numerous conversations with dog-owning residents and examination of their dog-registrations materials, it became apparent that Montebello's dog registration operates on an honor system with a low level of burden of proof.

The Pet Registration Form asks the owner to fill in the dog's breed, as well as sign a paragraph that this dog is not of the pit bull variety. In addition, the form asks for the pet's county registration and most recent vaccinations/inoculations. Only the Application for the Waiver of 2nd Pet requires the pet's photograph.

Furthermore, according to veterinarians, vaccination and county registration forms are not official breed documents because they are filled out by the owners; in many cases, dogs come from a rescue organization and an exact breed is not clear.

Hence the problem with these two dogs – their Montebello registration documents say American bulldog and Rhodesian Ridgeback, but knowledgeable residents claim the registration documents were knowingly falsified.

Mendoza said the association has consulted with its attorney and has informed the concerned residents "that management has exhausted all power. We don't have any tools to demand anything from them [two dog owners]. The association has no more legal tools to require any more proof."

As far as requiring the dogs to undergo a DNA test, Mendoza said, "We cannot force them to provide a DNA test."

Furthermore, Mendoza explained, the bulldog's owner has a doctor's note stating that the dog is a "companion animal," which now brings "fair housing into the equation."

"We are satisfied that it's an American bulldog," Mendoza said, "but our hands are tied. We've forwarded all the information to the Covenants Committee and they agree with management that we have no legal stance."

But Denise Cumbee, the resident leading the fight, disagrees. "The board and management does not have their hands tied by the bylaws," she says, "they can require more documentation if they choose. The bylaw doesn't limit the breed confirmation to the vaccination certificate. We want management and the board to take some additional action here to confirm the breed and get these dogs off of the property if they are pit bulls."

# Celebrate Earth Day by signing petition against chemical herbicides and pesticides!

hemical pesticides, including herbicides, fungicides, insecticides and rodenticides, endanger the environment and the health of living beings.

In 2015, the World Health Organization's International Agency for Research on Cancer joined the many scientists long concerned about those chemicals as well as Canada and France by classifying as "probably carcinogenic" the most common ingredient in herbicides called glyphosate. Earlier this year, Montgomery County banned the ornamental use of chemical pesticides such as Monsanto's Roundup and hundreds of others on public and private land.

Yet, those products have been used at Montebello for decades. In our community on a hill, chemical herbicides and pesticides deplete soil nutrients and contribute to soil erosion, leading to the thinning of our forest and underwood.

"Spraying over and over, year after year, on the same spots is not sustainable", said to us Michael Stachowicz, Turf Management Specialist at the National Park Service who manages the National Mall.

Montebello residents first petitioned the Board of Directors and Management on this issue in 2000, to no avail. Residents again launched a petition and presented it to the Board and Management on Earth Day 2014 and again in 2015. Incredibly, the current petition has been met with no substantive response from the Board members whom residents have elected to protect their interests.

As we prepare to celebrate Earth Day 2016 on April 22, what better way to advocate for the protection of Montebello's natural environment and of its resident humans and pets than to sign the petition below?

# Text of petition opposing chemical use on Montebello land and supporting a chemical-free land management policy

- 1- The first component of quality of life at Montebello should be to ensure that we live in a safe and healthful environment.
- 2- In 2000, a petition of Montebello residents called on the Montebello Board of Directors and Management for the use of chemicals, such as pesticides and herbicides, to be stopped immediately.
- 3- The chemicals that continue to be used at Montebello are known to cause cancer, neurological damage, birth defects, asthma and diabetes. They are a risk to the health of humans, pets, plants, soil stability and the broader environment (runoff).
- 4- On March 20, 2015, the World Health Organization classified glyphosate, the active ingredient in the Round-up herbicide used at Montebello, as "probably carcinogenic."
- 5- Herbicide use at Montebello over the last decades has been economically and environmentally costly to residents, with negative results that include reduction in tree, ground cover and grass density, as well as soil erosion.

Therefore, we strongly request that:

a- the Board of Directors and Management adopt and implement a chemical-free and sustainable approach to land management;

- b- that any company retained to care for our environment have recognized expertise and a track record in ecological land management;
- c- that tests be conducted by two separate independent laboratories on our children's playgrounds, pet areas, tap water and interior environment (carpets in common areas, apartments with pets) to check for any chemical contamination;
- d- that, prior to any new contract being drawn with any company, undisputed experts attached to non-commercial institutions, such as experts from the National Park Service, National Arboretum and/or the American Horticulture Society, be consulted on alternatives to Montebello's current approach;
- e- that the Board of Directors and Management form a consultative group composed of residents having proven expertise in public health and sustainable land management, as the Board has done on other projects such as lobby redesign; and
- f- that in the interval between the moment the old chemical-based approach is stopped and the new non-chemical policy is implemented, Montebello staff and contract employees limit themselves to mowing lawns, trimming and watering plants, and suppressing any "invasive plant" with hand and power tools.

### La Pietà

ietà, which means "pity" in Italian, is the name given to this world-famous sculpture created by Michelangelo Buonarroti and completed in 1499 AD. Unlike his statue of David, however, the Pietà is of normal, life-size proportions measuring five feet, nine inches high and six feet, five inches wide and was made from one piece of Carrara marble.

This exquisite work of art depicts the Virgin Mary holding the dead body of her son, Jesus Christ, just after his crucifixion, when he was taken down from the cross. Mary is depicted fully clothed while Christ,

lying across her lap, is completely naked, except for a loincloth. The figure of Mary is vertical while the figure of Christ lies almost horizontally suggesting the form of the cross. However, the structure of the Pietà is quite pyramidal. Moving downward from Mary's head, the figure widens progressively towards the rock which is the base of the sculpture. The gentle softness of the folds of the cloth is both a framework and a support for the entire sculptor. Jesus' face does not show any signs of his suffering while the serene, quiet stillness of Mary's face, with eyes downcast, projects an air of acceptance, at the same time her upturned left hand seems to be questioning why. The entire piece evokes a sense of sadness, of compassion, or in a word, pity.

One of the salient features of the Pietà is the ribbon across the chest of Mary, which bears Michelangelo's name and identifies the Pietà as the only sculpture that he ever signed. Initially, it was not part of the sculpture but was added later after another sculptor was



given credit for the work. Legend has it, that just days after it was first unveiled in the chapel of Santa Petronilla in old St. Peter's, the Pietà was being admired and discussed by a group of visitors from Lombardy. Michelangelo who was standing nearby overheard one of them say that it was sculpted by "Our Gobbo of Milan" referring to Cristoforo Solari, a contemporary and rival of Michelangelo. Solari was also known as il Gobbo (the hunchbacked). Rather than correcting the individual, Michelangelo kept silent, however, he returned at night and carved his name along the ribbon across Mary's chest.

The sixteenth century art historian Giorgi Vasari tells this tale in his book, *Lives of the Most Excellent Painters*, *Sculptors*, and *Architects*:

Such were Michelagnolo's love and zeal together in this work, that he left his name a thing that he never did again in any other work written across a girdle that encircles the bosom of Our Lady. And the reason was that one day Michelagnolo, entering the place where it

was set up, found there a great number of strangers from Lombardy, who were praising it highly, and one of them asked one of the others who had done it, and he answered, "Our Gobbo from Milan." Michelagnolo stood silent, but thought it something strange that his labors should be attributed to another; and one night he shut himself in there, and, having brought a little light and his chisels, carved his name upon it."

ichelangelo carved not only his name, but also the fact that he sculpted the Pietà. His inscription reads MICHAELANGELVS BONAROTVS FLOREN FACIEBA[T] (Michelangelo Buonarroti, Floren-

tine, made this) which is plainly visible on the sash running across Mary's chest. It is the only work he ever signed. Vasari also wrote that Michelangelo later regretted his passionate outburst of pride and swore never again to sign another of his works.

In 1972, on Pentecost Sunday, Laszlo Toth, an unemployed geologist from Hungary leaped over a railing at St. Peter's Basilica and attacked the Pietà with a hammer. With blow after blow, Toth knocked off the left arm of Mary, the tip of her nose, and damaged her cheek and left eye. However, the restoration of the statue, which took 10 months, left the repaired damage seamless and invisible to millions of observers ever since. During the painstaking restoration, workers discovered what appeared to be a secret signature mark on the piece. Hidden in the folds of Mary's left hand was inscribed the M, which is believed to stand for Michelangelo. Although Michelangelo did not sign his works, he apparently marked them as his.

he Citizens' Coalition for Police Accountability (CCPA) was founded in April 2010 by a number of private citizens, professionals, and several well-respected local, state and national organizations. This advocacy group comprised of grassroots citizens was organized due to its concerns of police misconduct, negligence and the absence of transparency regarding recent actions by Fairfax County Police.

Among several incidents of concern were the victims of a flawed system. You can read more about these incidents on our Incidents Page of the website.

In all of these cases and others, there has been a tack of transparency on the part of the Fairfax County Police Department. Victims' families have been unable to acquire information regarding these tragic incidents. Throughout the nation, police departments routinely release information which the Fairfax County Police Department fails to disclose.

If you or someone you know believe they have been the victim of misconduct by a member of the Fairfax County Police Department, you or they can obtain a Citizen Complaint form from the clerk at any Fairfax County District Police Station. When a complaint is filed with the Fairfax County Police, the CCPA will investigate all such allegations. Send a copy of your complaint form with a cover note requesting the CCPA to

further investigate the allegation.


