## From 1983 to 2023 Farewell to Montebello from Jack & Susie Quick

was one of the first to move into Montebello on February 19, 1983 into Building 2, unit 1101. I settled and officially purchased 2-1101 on March 24, 1983. Building 3 was under construction when I moved in and Building 4 came later. The sales office was in what is now Building 5.

I was 35 when I moved in and the average age was lower than it is now. The Huntington Metro Station opened up on December 17, 1983. Most of the residents worked and filled the shuttle bus to and from work. Once back from work, we took advantage of the MB amenities, bowling, hot tub, swimming, etc. We also played tennis on a plastic surface, put there because they thought a normal surface would add too much weight to the Community Center roof structure. It was very slippery and caused a few falls.

We walked the trail, which was all natural, carved out basically by the residents and visually shielded from the

adjoining properties. It got very muddy sometimes.

The residents were extremely active. Ten of us started the Montebello Half-Fast Social Club, which was not affiliated with Montebello. We were just neighbors who wanted

to do things beyond our campus. Gi-

useppe Cecchi, Montebello developer, was amused with the Social Club and had someone make us a flag that I still have. We took trips to New York City, did a pub crawl on St. Paddy's Day, and went to the Mall for concerts where I flew the flag so members could find us.

Giuseppe Cecchi, International Developers, Inc. (IDI) built many premier condominium communities. Richard Grizzard was his onsite representative and we became friends. Mr. Cecchi and Richard Grizzard offered me the first opportunity to lease the Montebello Café. The original design was set up to be a deli. Some of you may have seen the unused meat refrigeration unit in the previous market. I put careful thought into it for five minutes and turned it down. I think they were surprised, but I was at the University Club in DC and I told them I liked getting a paycheck. We continued to be friends anyway.

Back then, I think there were only 20 staff members in the office. It all seemed to work well, but the mission has changed and the activity level has skyrocketed. We had a few committees. I was on the Asset Committee, which was the forerunner of the Finance and Budget Committee. We were responsible to oversee the assets of the community and to make sure they were trans-

## **Full house**

he United States is overpopulated. That's right, we're full. Not just my assessment, but many in the scientific community agree. To make matters worse, we're in debt and our southern border is being overrun by migrants. Overpopulation, debt, and taking in too many migrants has caused a whole host of problems. Our classrooms are over-

crowded, and we are short teachers (4% nationwide and rising). The pandemic has contributed to lost learning. Many of our students are below par in math. We have many who are learning English as a second language. Our hospitals are short of beds and lack robust emergency care capacity. There are too few lab techs, nurses, pharmacists, and doctors. We aren't prepared for disaster or war casualties. Our police are overwhelmed by crime. They lack training and do not have the resources for modern forensics labo-

ratories capable of rapid DNA testing.

Overpopulation has also taken a toll on our environment. Our forests, grasslands, wetlands, and deserts are being bulldozed, destroying the habitats of our animals and plants to make way for subdivisions and strip malls. Each day millions of commuters are choking on the very smog they help create. Our rivers, lakes, bayous, streams, and bays are polluted and most of our fish, ovsters, and crabs from them are unfit to eat due to pollutants, much from plastic waste. We have a severe drought in the Southwest that is endangering our food supply and electrical power. Wildfires are now more common than ever ravaging our forests out west. Soon most of our coastal lands will be under saltwater from melting glaciers.

We need money to fix our infrastructure. Many of our roads, bridges, airports, electric power grids, waste management and clean water systems, irrigation canals, levees, and dams are kaput. None of these fixes will be cheap. The Hudson River Tunnel infrastructure project for example is expected to cost \$16 billion.

With a debt level at \$31.12 trillion, our nation's credit card is maxed out. Our options are to raise the debt ceiling



and incur interest payments that will eat away at other needed budget spending to fix our infrastructure, maintain our social services, and improve the environment. We can decrease spending with the same effect. We can raise taxes, but it still won't be enough. Most probably we will have to implement all of these measures to dig ourselves out of the hole we created.

To help stabilize our population, we need legislation to update our immigration policies and border enforcement to control the number of immigrants entering the United States. When looking at current immigration law, it is dazzling complex. Not even the Federal Acquisition Regulations come close. As a general plan, I propose:

- We allow temporary workers permits to work in the various fields such as agricultural, nursing, research, and construction as needed as currently defined by the U.S. Customs and Immigration Service.
- We grant citizenship to the current 800,000 Dreamers, those covered by Deferred Action for Childhood Arrivals (DACA).

We, on a case-by-case basis, approve bona fide political asylum requests

for those individuals as we have done in the past for the Vietnamese boat people, the Afghans who supported us in the war against Osama Bin Laden and the Taliban, and those fleeing the war in Ukraine. We should accept political prisoners like the 222 who had been held in prison in Nicaragua. The State Department needs to modernize taking advantage of Artificial Intelligence software to maintain a current "preapproved list" of those countries that are eligible and whose citizens could enter

the United States and apply for political asylum.

We approve citizenship or Permanent Resident Cards (green cards) to those under special circumstances such as those married to U.S. citizens or those deemed vital for the security or economic interests of the United States. We continue to allow those non-citizens who serve in the Armed Forces a path to citizenship.

We no longer have room or can afford to allow entry into the United States all those (around 272 million and increasing) seeking to avoid their economic depressed or failed states. If their country is not on the State Department's pre-approved list, these people would not be permitted entry into the United

States. No more requesting asylum at the border, entering the United States, and then disappearing before ruling. Applications for exceptions would be submitted abroad, either electronically or in writing. Finally, our borders need to be secured. Those that illegally enter the United States will be returned to their country of origin or other countries that will accept them. We must stop the drug cartel mules smuggling fentanyl across the border that kills 150 people here each day.

Somethings we can do to mitigate the problem of economically depressed states is better target our foreign policy to assist those in need of help or those that want to stay in their native country. For example, we could lift the failed 61-year-old trade embargo against Cuba. Another example would be to ensure that we uphold our treaty to deliver 1.5 million acre-feet of water from the Colorado River to Mexico each vear - free of salt and chemicals from our agricultural runoff canals like we are doing now, making that water essentially unusable. We should encourage others to better fund international organizations like the World Food Programme, World Health Program, and World Bank; and increase our fund-



ing to the Refugee and Humanitarian Assistance Program. Finally, we need plans and preparedness to be able to respond more quickly and completely to humanitarian operations using DoD assets with their hospital ships, air transport, and offshore shipping assets.

We see what is happening in the world: the wars, the famines, droughts, wildfires, melting glaciers, and diseases. It is heart-breaking, but we can't fund the whole world, nor can we accept everyone to live here. We are full. The United States must make hard decisions.

#### Good deaths, and bad

Hearing about the earthquake in Turkey and Syria brought to mind Philippe Aries' The Hour of Our Death. In it he describes The Good Death, as it was thought of a few centuries ago. In bed in one's home, the room filled with the significant individuals from one's life, the person exchanges expressions of gratitude, affection, contrition, and final goodbyes with those present. A priest administers confession and the Last Rites. The person peacefully dies. No pain, no terror. (A caricature, based on this notion of a proper death, is in Puccini's Gianni Schicchi).

By contrast, in Turkey and Syria there are persons whose buildings have collapsed on them but not killed them. Most are probably unable to move and may be having difficulty breathing. It is dark and cold; hypothermia is limiting how much time searchers have to find and extricate them. One avoids thinking about what their thoughts and feelings must be.

In the 1960 earthquake and tsunami in southern Chili, hordes of would-be helpers flooded down from the north, whom organizers now also had to feed and house. They became an additional problem. We won't do that, but we can contribute to appropriate charities, and we should. Just watch out for con artists, who feast on this sort of opportunity. – *Richard Titus* 

## Voting: an obligation

Based on our recent history, it would be easy to feel overdosed and fed up with voting.

We have had primaries, general elections, and run-off elections. Our TVs have been taken over by political ads, poll soothsayers, and talking heads who have "expert" opinions on every single issue. We may reach the saturation point and scream "enough already!" Not yet.

Our next election will be upon us in March 2023. The residents of Montebello will be called upon to elect three new members for the Board of Directors, those civic-minded volunteers who take on almost a full-time job, without compensation, to make decisions that impact all of us. In some past elections, it was a challenge to meet the established minimum number of voters to make the election legal. Shame on any of us who did not participate.

Once volunteers step forward to place their names on the ballot, the process starts.

We will be provided biographies on all the candidates. We will have an opportunity to meet the candidates, ask questions of them in a Zoom forum on Sunday, February 26, and evaluate who should earn our vote. An in-person meeting would be preferred, but for a multitude of excellent and wellthought out reasons the forum will be by Zoom. And finally, we will cast our votes for the men and women who we determine will best represent our interests.

As with so many things, I also have VERY strong opinions about our Montebello election process.

✓ Voting is an obligation, made so much easier by recent changes in the Montebello elections. If one does not vote, both residents and absentee owners, our opinions belong in the trash bin. One has an opportunity to cast a ballot. If one does not do that, we have no right to share opinions about how our complex is managed. That having been said, place a piece of duct tape over your mouth and "shut up." Elections demand participation – no vote, no whining voices after the election.

When we do vote, we also have an obligation to select the very best candidates based on an assessment of their personal history and campaign statements. Evaluate the candidates, especially in the Meet The Candidates Zoom forum. Submit questions, think about the replies, and vote your conscience. Do your homework.

Beware of "one issue" candidates. We would all like lower condo fees just as the folks in hell would like ice water, but is it realistic? Acting as our fiduciary, the Board of Directors must make some very tough decisions. Their decisions are driven by many factors that are often beyond their collective abilities to control: inflation, prevailing wages in the industry, code compliance, and the age of our properties, to name just a few. Add to that the expressed wishes (demands?) of the owners to protect our investments and to continually improve the quality of our lives by adding even more amenities.

Everything has a price, and every decision requires a cost-benefit analysis. There are very few free rides in life. There are other issues besides condo fees. Opinions without solutions are like elbows; most of us have one or two.

Ask yourself the question: How involved has the candidate been in Montebello's day-to-day activities? Does the candidate even live full time at Montebello? Any current Board member will attest to the fact that being here lets them keep a finger on the pulse of the community, not to mention having "face time" with residents at various Montebello functions. That is difficult to do from afar. Have they served on committees and played a role in the art of compromise that is so necessary to craft workable decisions?

Multiple What background does the candidate have in management on the scale that Montebello presents? Even the most dedicated and well-intentioned candidates can be easily overwhelmed by the complex legal, financial, personnel, and administrative responsibilities that they assume once on the Board. We have had past Board members who rose to the challenge and have done magnificent jobs. However, on-the-job training is risky at best. Seasoned professionals who have managed money, people, facilities, and time are ready to do just that at the first Board meeting after the election.

At the Meet The Candidates Zoom forum, how did they answer direct questions posed by the attendees? Did they recite platitudes, fail to answer the question, or tap dance through a non-answer? Were they honest enough to simply say "I don't know," or "I would have to do research on that question" if appropriate. A lot can be learned about an individual by how he/she fields an unrehearsed answer to a potential constituent's question. Communication skills coupled with honesty are a mandatory personal attribute.

Do not overdose on voting yet. Our next election will impact each one of us probably more directly and personally than any election we have participated in during 2022. Be involved. Be informed. With the ease of voting at Montebello, there is no excuse not to be a shareholder in deciding who makes the decisions that impact all of us.

An aside, and it is a plus, to date, we have not had a post-election denier. Yet.

This represents my opinions alone and has no connection to those who so admirably plan, manage, and run our elections.

Finally, I must give a tip of the hat to those who volunteer to serve on our Board. Past and present, they have collectively looked after all of us and our homes. Well done!

I think the recent election flyers put under our doorways is very inappropriate. Board members (past and present) should not be able to use their elected offices to directly influence future elections as a group by asking people to vote for their endorsees. If Board members as individuals want to support other individuals on merit, they should do so without using their elected official status. Early each year a letter goes out from Montebello asking civic-minded residents to stand for election to the Board of Directors. It does not mention that all candidates are not created equal.

When this year's election cycle ends, six or seven of the seven available Board positions contested over the past two years will have been won by candidates endorsed by members of the Board of Directors. One or none of these positions will have been won by the six candidates who were not endorsed by Board members.

From the viewpoint of democratic process, these results create bad optics. The message appears to be that potential candidates who are not established Friends of the Board need not apply. Why bother in the face of the very long odds?

The results could also inspire the cynical to view the Board as exclusive, close-knit, self-replicating, and not very transparent (Who paid for this year's Board endorsement flyer?).

If we wish to maintain functioning democratic norms in Montebello, I believe we could make a good start by adopting as policy the philosophy of the Hatch Act. This law prohibits federal officeholders from using their official authority or influence to interfere with or affect the result of an election; for example, using their official titles or positions while engaged in political activity.

Board members should refrain from using their titles and positions to influence Montebello elections. In the spirit of Hatch, it would be even more healthy for the democratic process at Montebello if they stood clear of the elections altogether.

In the interest of transparency, I also believe we should adopt as Montebello policy the standards that apply to the campaign materials used in our state and local elections; *i.e.*, clear identification on the materials themselves of the people who paid for them. \*

At the Board Work Session on February 28th, the flyer was discussed in light of the numerous inquiries it has caused. The President of the Board read notes from his discussion with the Association Attorney. The President said that the flyer was entirely legal. The President also called on the Head of the Election Committee who stated that the flyer did not violate the current Election Regulations.

While this may be true, I think that the flyer creates significant problems for our Association. First and foremost, it introduces a discordant note into our Association. It damages our friendly social environment. And, it distracts us from our focus on what is best for our Community. Several Owners think it crosses the line into unethical behavior. That is not an unreasonable point of view.

To be clear, for a Board Member to say, "My friend, Tom, is running for the Board and I think he'd do a great job," is not a problem. But saying, "I'm a Board Member and many of us Board Members say we need Tom on the Board" probably is. What's the difference? In one case you are stating your support for a Candidate. In the second, you are implying that you are acting on behalf of the Association. To my way of thinking, this is using the authority of your position in an inappropriate way. Obviously, opinions vary. It is for the Voters to decide if they wish to encourage this kind of behavior.

In addition, during the Candidates' Night discussions, the Candidates were asked if they would be Independent. I stated that I would be Independent. I feel strongly that I have a fiduciary responsibility to be Independent, to represent all of the Owners. In the short time I was on the Board, that Independence saved the Association \$60,000 on the EV Charger effort, obtained Structural Inspections to ensure our Towers are safe, and saved a few thousand dollars on various other contracts. I will take a similar Independent approach should I be elected now. I will leave it to the Owners to consider this flyer and decide how Independent the various Candidates will be. 💠

My favorite analogy to describe Montebello is that it's like a high school. We have our sports teams, artsy types, cute couples, computer nerds, smart misfits, cool popular kids, dances and parties, a cafeteria, and the principal's office. We also have a student council, the board of directors, that holds elections every year. Like all student councils, ours has candidates who are passionate about governance and keeping Montebello financially strong. All the candidates have decades of professional experience in the government and in the private sector. Unfortunately, because nine strong personalities serve on the board, the rest of the student body occasionally has idealogical and personal conflicts, accusing the board of being "clique-y" and tonedeaf to the constituents' concerns.

Our current board election is laying bare these us vs. them perceptions that the board is an exclusive society with

members invited to join other like-minded individuals. It became especially apparent when four current board members and two committee chairs publicly endorsed three out of four board candidates by slipping a flyer under the door. Although this endorsement is neither illegal nor against the rules, it sends a very clear message to the voters: these are our people, "we share the same views," and voting for them will give us a seven-person majority to accomplish our agenda. Essentially, a voting bloc.

At the last board work session, two board directors, Rolf Dietrich and Tom Harrelson, spoke out against the endorsement flyer. "It's very good that we're giving our personal opinion. But if we say that we are board members, then that implies that the board is endorsing it," Dietrich said. "Some people thought it was coming from the board. We need to set our standards a little higher, where our ethics are beyond reproach."

Likewise, director Harrelson said a line had been crossed between board impartiality and election influence. "I agree that as an individual, you have a perfect right to endorse whoever you want and to vote for whoever you want. But to make it look like you're using the wording 'board endorses,' that has an ethical value to it and I am concerned about it."

In their statements on the subsequent pages, board members insist that endorsing board candidates is nothing new and has been going on in one form or another for decades. I've lived here since 1996 and cannot recall such blatant anointing of candidates that goes beyond old-fashioned cronyism. Whether it's legal is not the point – the optics are terrible and it gives the impression (to use an overused term), that board elections are rigged in favor of hand-picked candidates.

Don't get me wrong. I very much admire and respect the abilities of our board members who put in innumerable free hours into our governance. Before the pandemic, I diligently attended every board meeting and marveled at




the breadth of knowledge, professionalism, and attention to detail our board brought to their responsibilities. Because I hold our board in high esteem, it's very disappointing when some of them use under-handed tactics to get their cronies elected and then act as if we're the ones in the wrong – they didn't break any election rules because election rules don't mention endorsements. So theoretically, they're in the right. But the owners are smart people and can see through the gaslighting and manipulation of facts.

In future board elections, I respectfully ask that Montebello's owners be allowed to make their choices based on the available information and meetings with candidates without any patronage or influence from the board. Trust us to make our own decisions. \*

### In view of election impartiality and transparency, is it appropriate for board members and committee chairs to endorse and promote specific board candidates for the upcoming election?

The election flyer that was delivered to unit doors is perfectly acceptable under Election Committee guidelines, which are updated and approved every year by the Board of Directors.

For this year's election, a group of people who are involved in Montebello governance, collectively have more than 60 years' experience in the Board or on the governance committees, and who have worked with all of the candidates, decided to endorse some of them. This practice dates back to 2005 when two slates of candidates were running on opposing priorities. Also, last year owners received campaign materials representing two different groups and perspectives. Endorsements have always included sitting Board members.

As our attorney has advised, after reviewing the recent flyer, this is completely within their rights as Montebello owners:

"You have asked for my opinion regarding whether Montebello Board and/or Committee members are permitted to endorse candidates for the Board. There is nothing in Virginia law or the Montebello governing documents that would prohibit the endorsement of candidates for the Board by existing Board or Committee members. However, there is an exception for members of a Committee that is in some way involved in managing the election, such as a Nominating or Elections Committee. They should remain neutral so that the integrity of the election is maintained. Also, the endorsement cannot come in any document that purports to be an official Board or Association communication.

"As long as anyone having anything to do with managing the election stays neutral, I think that a Board member, as an individual, can feel free to give his/her opinion on any candidate or candidates.""\* Regarding transparency, at the bottom of the flyer were listed the names and unit numbers of the candidates and of the endorsers, as specified by the Election Committee guidelines. The flyer stated: "Endorsed by current or former Board Members and Committee Chairs." That's all it was, six people with Montebello governance experience exercising their individual opinions as owners.

No Montebello resources were used for these flyers, and funding was not an issue for past years' flyers nor should it be this year. All owners are entitled to privacy with regard to their personal finances, and knowing who paid how much has absolutely nothing to do with the election itself.

This year there are four candidates for three Board seats. It is unfortunate, but there has to be one loser. I have worked with all four people and – based on their contributions to Montebello, their work on committees and/or the Board, and their philosophies about fiscal policy – I ranked them. I have endorsed the top three. Many owners have sought my opinion at every election for the past four years. This year, as in all years, all owners are free to analyze, to evaluate, and to reach their own conclusions as to for whom to vote. ❖

I have attached a copy of the Guidelines for Candidates document [page 15, ed.] which the Elections Committee distributes to each candidate as soon as his/her candidacy is official. This document has remained basically the same for at least the last eight years. Each year the Election Committee does minor updating and submits the document for approval by the Board which discusses the document at a public work session and then votes on it at a regular Board meeting. This document states that campaign material must be "non-defamatory" and "must include the name(s) and unit number(s) of the person(s) responsible for the material." The piece of campaign material distributed on Candidates Night does not violate any of these clearly defined campaign guidelines.

In the Fall (well before the next election) the Election Committee will be submitting all official documents for the 2024 election to the Board of Directors. The agenda containing a list of these documents will be sent to everyone in the MML announcing the date of the appropriate Work Session and regular Board meeting. I encourage anyone interested to attend these meetings at which the Guidelines for Candidates will be discussed.

The Elections Committee has not yet had time to discuss this issue, so what follows is <u>my personal opinion</u> and not that of the elections committee.

I feel that people who volunteer to be on the BOD or on committees should not have to give up their rights as owners to publicly voice their opinions. As an informed voter I find endorsements useful because they often provide more information on a candidate's policies and vision. This is especially useful when the person(s) who is doing the endorsing has worked with the candidate, or when the candidate is someone unknown to me. The Election Committee is, of course, an exception. The integrity of the election requires that, both individually and collectively, the members of this committee remain neutral. The Election Committee has not, will not, and should not endorse any candidate. 💠

Finally, it should be noted that in 2002, it was common for Committees (other than the Elections Committee) to invite candidates to their committee meetings so members could hear the candidate's statements and engage in conversation with the candidates. This event was a formal committee agenda item and the ensuring discussion took place during the formal committee meeting. The Board and the Elections Committee agreed that this practice needed to be discontinued as it exceeded the terms of reference for committees. Additionally, it forced some members to hear campaign speeches that they would prefer not to hear. This policy was changed to one where committees could invite candidates, but they only could speak after the committee adjourned thus making attendance a voluntary activity.

As a former Board member for 15 years, I have never given up my right to express my recommendations for individuals who I believe have the necessary experience and skills to work tirelessly for owners to make Montebello's vision, mission and values a reality. I review all candidates' skills, expertise, professional experience, and experience with Montebello's governance in making my selections and never judge a candidate on a single criterion. I seek to have a board with a diversity of skills. For example, there was a time when the Board had three professional engineers; it's unlikely I would have endorsed a fourth engineer.

I have always endorsed candidates and will continue to do so in the future.

It distracted from what should have been the robust discussion of condo-wide issues that has characterized previous "Meet the Candidates" sessions in the past. I would guess that the challenges of organizing a volunteer team of the size needed to deliver the flyer to all units on all floors of all buildings had something to do with that timing.

However, as someone who has been a volunteer in many campaigns from national elections to association boards — I am confident that the endorsements of past and incumbent officeholders is not only appropriate, but a time-honored and much sought after tradition. That goes for Montebello Board elections as well.

Endorsement by past and incumbent office holders is also legal under Virginia statutes. As Montebello's attorney Bob Segan has written:

## **Guidelines for Candidates**

1. Nominating petitions for the candidates addressed above have been received and validated. This memorandum constitutes acknowledgment of your petition and provides guidelines and information for your use during the period prior to the Annual Meeting and Election.

2. The Board of Directors (BOD) has adopted a Code of Conduct, and has directed all candidates to sign a statement that they have read and understood the code of conduct and agree, if elected, to honor and be bound by the terms stated therein. A copy of the Code of Conduct (AR 95) was included in your Call for Candidates packet.

3. The Election Committee has recommended, and the BOD has approved, the following guidelines:

#### A. Campaigning

Election material is expected to be dignified, non-defamatory, factual and in keeping with the community standards. All election material must include the name(s) and unit number(s) of the person(s) responsible for the material. Candidates who wish to distribute election materials to individual units are required to check at the Association Office for the list of residents who do not desire to receive such materials.

Items placed on the B3 bulletin boards may not exceed 3" x 5".

Solicitation by door-to-door in-person campaigning or by placing flyers in the lobbies or in other common elements is prohibited. However, the Election Committee will provide an easel in each lobby displaying a copy of each candidate's biography.

On the day before the Annual Meet-

ing Election Committee volunteers will provide voter assistance in the lobby of each building. During this time, all campaign activities will be restricted to the lower level of the lobby in each building.

On Election Day no candidate will be allowed in the room where the voting is taking place, except to vote.

Candidates may attend Committee meetings as unit owners. No campaigning is allowed during committee meetings. At the conclusion of the meetings, candidates can have Q&A sessions with Committee members.

Clubs will establish their own criteria and procedures for meeting with candidates. All candidates must be given the same treatment.

A list of committees and clubs is available in the Association Office.

#### **B. Election Procedures**

The order of listing of the candidates on the ballot will be alphabetical.

Candidates will be listed on the ballot by name only (no degrees, ranks, etc.)

An asterisk (\*) will be added next to the name of any candidate who has not agreed to sign the Code of Conduct, and it will be marked the same way on the ballot.

The three candidates receiving the highest vote totals will win 3-year terms.

#### C. Meet The Candidates Night

The Election Committee and the Board of Directors will sponsor a "Meet the Candidates Night" via ZOOM on Sunday, February 26, 2023, starting at 7:00 p.m. Candidates will be provided an opportunity to express their views orally on any issue. The Chair of the Election Committee (or designee) will moderate this forum. Candidates will be allowed two (2) minutes to address the meeting with prepared remarks if they wish to speak. Following the prepared talks, there will be a question and answer period. Closing statements are optional and should be no more than 2 minutes in length.

Personal attacks directed toward other candidates, the Board of Directors, the Management, or members of the community, whether originating from the candidates or the audience, will not be tolerated.

Candidates' remarks shall be forward-thinking and not focused on historical projects or decisions.

#### **D. Briefing By Counsel**

On or about Tuesday, March 21, 2023, at 7:00 p.m. or prior to the next Work Session, the Association Counsel will meet with the newly elected Board members and current Board members to discuss the responsibilities and duties directors have to the Association and to elect Board officers.

All members of the Board of Directors will be requested to sign the Code of Conduct.

### "Ukrajina eto ne Rossia" (Ukraine is not Russia)

Leonid Kuchma, president of Ukraine 1994-2002

Russian propaganda that Ukraine is not a separate and independent country but part of Russia is no longer working, neither inside Ukraine nor outside. Russia has responded by bombing residential parts of Ukrainian cities, killing residents, including children. But fighting for your identity is a powerful motivator and does not lend itself to simple calculations of military strengths. President Volodymyr Zelensky is pointing to Ukrainians' ability to fight as he is asking the West for support – it will not be wasted.
